Note: 1) The invitation letter and other documents may be in the form of fax, photocopy or print out, however, the Consular Officer has the right to request the applicant to provide the original versions.

- 2) If necessary, the Consular Officer may require the applicant to provide other proof documents or supplementary materials or require an interview with the applicant.
- 3) The Consular Officer will decide on whether or not to issue the visa and on its validity, duration of stay and number of entries depending on the specific conditions of the applicant.
